

## Digital Millennium Copyright Act (“DMCA”) Notice

Comcell, Inc. acts as a “Service Provider” under the DMCA. As a result, third party materials that are not owned or controlled by Comcell may be transmitted, stored, accessed or otherwise made available using Comcell’s services. You agree to notify Comcell if and to the extent any situation arises wherein you believe any material available through such services infringes a copyright. Any claimant must notify Comcell using the notice procedure for claimed infringement under the DMCA and provide the following:

If you believe that your work has been copied and has been posted, stored, or transmitted through Comcell’s services in a way that constitutes copyright infringement, please submit a notification pursuant to the DMCA by providing Comcell’s designated agent the following written information: (i) an electronic or physical signature of the person authorized to act on behalf of the owner of the copyright interest; (ii) a description of the copyrighted work that you claim has been infringed upon; (iii) a specific description of where the material that you claim is infringing is located; (iv) your address, phone number, and email address; (v) a statement by you that you have a good-faith belief that the disputed use is not authorized by the copyright owner, its agent, or the law; and (vi) a statement by you, made under penalty of perjury, that the above information in your notice is accurate and that you are the copyright owner or authorized to act on the copyright owner’s behalf.

Consistent with the DMCA and the rules promulgated by the U.S. Copyright Office under the DMCA, Comcell has designated agents to receive notices of claimed infringement. Pursuant to 37 C.F.R. § 201.38, Comcell has designated the following agents for each applicable entity within its company group:

Notices of claimed infringement subject to the DMCA should in all cases be directed to the agent set forth above.

Comcell will respond expeditiously to remove or disable access to material Comcell determines may be infringing and will follow the procedures specified in the DMCA to resolve the claim between the notifying party and the alleged infringing party.

Additionally, if a Comcell user is identified as a repeat infringer, Comcell may take various actions, including issuing alerts, requiring specific actions by the user, suspending services, applying interim measures, or, when necessary, terminating the user’s service(s). Comcell reserves the right to suspend or terminate services at any time, with or without notice,

including where Comcell believes a user to be infringing upon copyright or other intellectual property rights.

Comcell has no obligation to monitor its services, but may do so and disclose information regarding use of the services for any reason if Comcell, in its sole discretion, believes that it is reasonable to do so, including, without limitation, to: (i) satisfy laws, regulations, or governmental or legal requests, (ii) operate the services properly, or (iii) protect itself and its customers and users. Comcell may immediately remove material or information from Comcell's servers, in whole or in part, which Comcell, in its sole and absolute discretion, determines to infringe another's intellectual property rights or to violate its Acceptable Use Policy.
